to provide for the establishment and incorporation of the Sikkim Global Technical University in the State of Sikkim, and to confer the status of a Private University thereon and for matters connected therewith and incidental thereto.

WHEREAS, with a view to provide major boost in terms of academic upliftment in all spheres of knowledge it is essential to impart education in almost all areas including Management, Engineering, Law, Information Technology & Communication, Medical, Nureing, Insuranco, Behavioural Science, Fine Arts, etc. to the youth at their doorsteps;

AND WHEREAS, Indira Gandhi Computer Saksharta Mission registered under Indian Trust Act, 1882 has having registration number no. 4524 registered on 17th September, 2008 by sub-registrar Government of NCT, New Delhi, Government of India;

NOW THEREFORE, Indira Gandhi Computer Saksharta Mission (IGCSM) intends to establish Sikkim Global Technical University in the State of Sikkim with the objective to provide Higher Education with skilled and entrepreneur courses in Sikkim through world class infrastructure and international networking which shall catalyse not only the surrounding region but the State as a wholo.

In this regard, it is is informed that as per the Sikkim Global Technical University Act, 2023 (Act No.9 of 2023), the Sikkim Global Technical University, Link Road, Bhutia Basti, District. Namchi, Opp. to Reliance, Sikkim – 737126 has been established as a State (Private) University by the Government of Sikkim with effect from 01.08.2023 and notified vide Notification No. 48//DIR [HE]/EDN dated 14.09.2023. Accordingly, the name of the university has been included in the list of universities, as maintained by UGC under Section 2(f) of UGC Act, 1956. The list is available on the UGC website www.ugc.sov.in.

The University may note and adhere to the following:

- 1. The inclusion of the name of the University in the list of universities maintained by the UGC does not by itself allow the University to make admissions in its programmes. This may be done only after creation of required academic and physical infrastructure facilities, including library, laboratories and appointment of teaching and supporting staff as per the norms and standards laid down by the UGC and Statutory Council(s) concerned.

The University is requested to submit detailed information (soft copy only) in the prescribed format [available at UGC website at the link https://www.ugc.gov.in/oldpdf/proformaprivateun/versities.pdf along with supporting documents duly attested by the Registrar of the University within a period of 3 months from the receipt of this letter. The University is also requested to upload the filled in format and appendices on its website by giving a link on the home page so that the information is accessible to the students and general public.
